

**MINUTES  
HANDICAP COMMITTEE  
PINEHURST COUNTRY CLUB  
March 22, 2010**

Meeting was called to order at 4 pm.

**PCC Staff Report:**

Nate was not present because he had a meeting of Pinehurst employees with Mr. Dedmond, Jr.

Jackie Meyer passed along that Nate prepared and distributed to all the Starter Shacks and appropriate PCC offices the new conversion charts for Courses 1 – 8. These charts are on Golfnet. Jackie emailed the same charts to the Handicap Committee Reps. All organized golf representatives of the handicap committee were asked to replace the new charts for the old in the respective member's locker rooms.

**Committee Reports:**

**Birdies** – Laura Harmon: reported the new handicap conversion charts were dated and posted in the Birdies book. There was nothing else to report.

**Scramblers** – Lou Mongelluzzo. He was a little late but had nothing to report.

**MGA** – Dave Lee: The MGA is permitting any member of the organization to play from the green tees. Dave set up a conversion chart for MGA that is posted at every starter shack. Dave also mentioned that the updated conversion charts were posted in the men's locker room. He noticed the new charts for courses 1 and 3 were different from the old charts because of the re-rating of those courses in the fall of last year.

**Rules** – Ellen Shulby: Not present.

**WGA** – Lisa Akers and Pat Anderson: Not present. Jackie will meet with Lisa and Pat to discuss WGA members playing from different tees.

**At Large Members:** Don Staley and David Johnstone: Present, but no report.

### **Monitoring/Posting of Tournament Scores by Handicap Committee:**

After some discussion of these procedures, Jackie will rewrite and resend new procedures. New instructions will be added as to how a committee member can post a penalty score from his/her home computer and from the club computers for someone who fails to post a score after a tournament.

Jackie will also contact the Tournament Office to discuss procedures regarding adjustment of scores on a scorecard. If scores need to be adjusted, the PCC Staff prior to handing over the scorecard to the Handicap Committee Representative should do it.

Jackie will also discuss with the Tournament Office the requirement to have all participants posting number on the scorecards.

Members of the Handicap Committee discussed and agreed all Tournament Instruction sheets should contain information regarding the issuance of a penalty score should the individual golfer fail to post his score as a "T" score within 7 days of the tournament.
