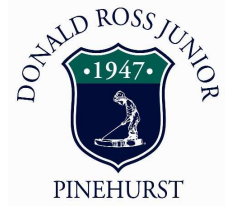


63RD DONALD ROSS JUNIOR CHAMPIONSHIP



ELIGIBILITY and CONDITIONS OF COMPETITION

ELIGIBILITY

Entries are open to golfers born male who are age 17 and under. Play will be contested in three age divisions: 11 and Under Division, 12 to 14 Division, and 15-17 Division. Contestants must not have reached their 18th birthday by Tuesday, December 28, 2010. A separate Father/Son competition will be contested for players and their fathers/guardians on Thursday, December 30, 2010. Players must have participated in the 63rd Donald Ross Junior Championship in order to be eligible to play in the Father/Son competition.

CONDITIONS

Field: The field for the 63rd Donald Ross Junior Championship will consist of three age divisions. The 11 and Under, and 12 to 14 Divisions, will compete 36-holes on Pinehurst No. 1. The 15 to 17 Division, will compete in 36-holes of stroke play, one round each on Pinehurst No. 4 and No. 5.

Rules for Play: The Championship Rounds shall be played in accordance with the USGA Rules of Golf 2010-2011 and the Local Rules as defined by the 63rd Donald Ross Junior Championship Committee. Conduct unbecoming by a player may result in disqualification.

Carts/Caddies: Players are required to walk. Carts and Caddies are not permitted during Championship Rounds. Spectator carts are permitted for a \$34 (inclusive) fee.

Dress Code: Pinehurst Resort and the 63rd Donald Ross Junior Championship Committee require collared shirts be worn at all times during the Championship, including practice rounds and Championship rounds. Shorts are permitted but must be of appropriate length.

ACCEPTANCE

All completely executed applications must be **RECEIVED** no later than **5:00 PM Eastern Daylight Time TUESDAY, NOVEMBER 30, 2010**. No entries will be accepted incomplete or after the deadline. The final field will be determined and confirmations or regrets sent to applicants via U.S. Mail. Submission of application does not in itself guarantee acceptance. Division will have a maximum number of players allowed as follows:

- 11 and Under Division – no limit
- 12 to 14 Division - 72 players, no alternates
- 15 to 17 Division - 176 players, 16 alternates

Players will be entered on a first received/first accepted basis.

During the application process, applications received will be posted on the Championship website. Names posted at this location designate only applications received and does not guarantee acceptance. Please make checks out to Pinehurst, LLC or provide complete credit card information on the application form. Checks will not be cashed and credit cards will not be charged until the close of entries on Tuesday, November 30, 2010.

Any player withdrawing prior to the close of entries will receive a full refund. Cancellations made after the closing date but before December 22, 2010 will be refunded less a \$30 processing fee. Those applicants not accepted receive a full refund of their application fee (credit for credit cards, checks will be returned by separate mail).

Entries are subject to rejection at any time, including during the Championship. The reason for rejection may include unbecoming conduct by contestants or parent/guardian.
